

GROVE CITY COUNCIL REGULAR MEETING TUESDAY JUNE 17, 2025 MINUTES

The Grove City Council met in regular session on Tuesday, June 17, 2025 at 4:00 PM with Mayor Ed Trumbull presiding. Members present were Peggy Steed, Andy Stewart, Marty Dyer, and Ivan Devitt. Also present was City Manager, Debbie Bottoroff; City Attorney, Darren Cook; City Treasurer, Lisa Allred; Convention and Tourism Director, Brent Malone, and Municipal Clerk, Laura Davila.

PUBLIC COMMENT:

Mayor Trumbull recognized Debbie Bottoroff for her 21 years of service to the City of Grove and presented her with a plaque in honor of her retirement at the end of the month.
