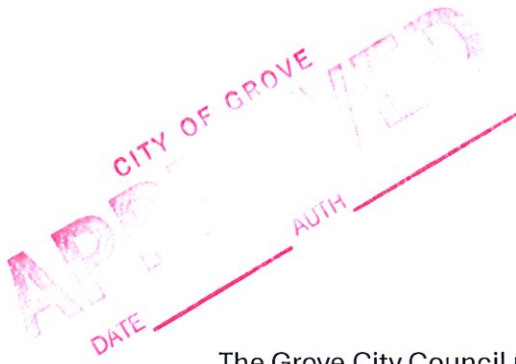




**GROVE CITY COUNCIL

The Grove City Council met in regular session on Tuesday, September 2, 2025, at 4:32 PM with Mayor Ed Trumbull presiding.
