- ✓ Junk, appliances, furniture, grass clippings and yard debris accepted.
- ✓ Grass clippings and leaves must be bagged.
- ✓ Yard debris must be bundled and tied with degradable string or twine. Materials larger than four (4) inches in diameter or four (4) feet in length will NOT BE PICKED UP.
- ✓ All items must be placed along the street in the city's right-of-way prior to the crews stopping at each residence.
- ✓ Crews are not responsible for picking up items that are not in place when they stop for pick up.
- √ To assure items will be picked up; residents may place items at the curbside beginning April 10;

Items excluded from Curbside pick up: commercial & agricultural waste, tires, batteries, motor oil, paint, varnish, thinner, pressurized gas cylinders, medical wastes, pharmaceuticals, TVs, electronics, ammunition, explosives, and items too large to fit in the garbage truck compactor bin.

Items accepted at the Grove Wastewater Treatment Plant

(Turn N at 3rd Street/S Cherokee Intersection and go approx. 2 miles North to the plant entrance)
