

**PUBLIC NOTICE

AMENDMENTS TO SPECIFICATIONS
THE PROJECT SHALL BE BID ACCORDINGLY**

A. Bid Bond

A Bid Bond in the amount of five percent (5%) of the total bid amount shall be attached to all bids as a guarantee that the successful bidder will enter a contract and file the required bonds no later than ten days after Notice of Award. A cashier's check made out to the City of Grove may be submitted in lieu of a bid bond.

B. Bonds Required

Performance and Statutory Bonds, each in 100% of the bid amount, covering faithful performance, and payment of all obligations arising thereunder, will be required by the City of Grove. A warranty bond in the amount of 100% of the bid amount covering defective workmanship will be required for a period of one year after acceptance of the project by the City of Grove. Premiums for the performance, statutory, and warranty bonds are to be included in this proposal.

The successful bidder shall deliver the required bonds no later than ten (10) days after Notice of Award. The bonds shall be dated on or after the date of the Notice of Award. The Bidder shall require the Attorney-in-fact who executed the required bonds on behalf of the surety to affix thereto a certified and current copy of the power of attorney.

C. Insurance

The policies of insurance shall be executed by insurance or indemnity carrier authorized to do business in the state of Oklahoma and shall in all respects conform to the required of the Governmental Tort Claim Act, Title 51 Oklahoma Statutes Section 151 et seq. With liability limits to be no less than the amount specified therein and with City to be an additional insured on all such required policies of insurance.

D. Weather Days

Weather days will be allowed as needed, and must be approved by the City of Grove.

E. Deadline and Award

DEADLINE – to submit bids is 10 a.m. on November 3, 2023.

AWARD – All Bids received will be presented to the City Council for consideration on Tuesday, November 7, 2023 at 4:30 p.m. in Room 7 at City Hall, 104 W. 3rd Street.
