Permits issued for placement or replacement of Mobile Homes or Manufactured Homes within a RMH Zoned District or a Non-conforming Manufactured Home Park expire and become invalid within one-hundred eighty (180) days of issuance.

Removal of a Mobile Home or Manufactured Home from a RMH Zoned District or a Non-conforming Manufactured Home Park does not require a permit.

ALL Mobile Homes or Manufactured Homes transported, set-up, or connected to utilities after January 21, 2014 require a final inspection and issuance of a Certificate of Occupancy prior to occupancy.

I hereby certify that I am the property owner and that the information provided in this application is true and correct to the best of my knowledge. The work shall comply with all provisions of laws and ordinances, whether specified or not. The grant of a permit does not presume to give authority to violate or cancel the provisions of any federal, state, or local law regulating Mobile or Manufactured Homes.
